

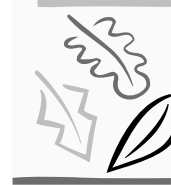

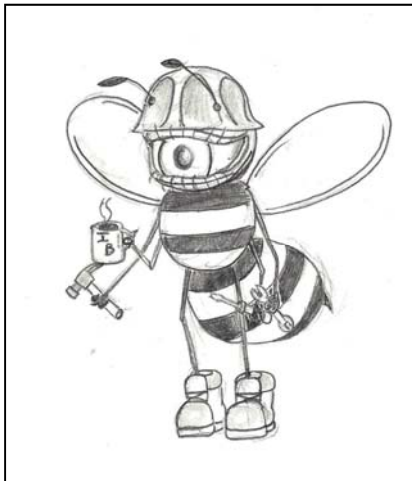

The new week goes from Sunday to Saturday. It is your responsibility to notify your visitor of time and dress code. It is your responsibility to sign up for your desired visiting time. Visits MUST BE scheduled accordingly:  
 Saturday, Sunday and Monday – MUST BE submitted by Thursday at Midnight  
 Tuesday MUST BE submitted by Friday at Midnight  
 Wednesday MUST BE submitted by Sunday at Midnight  
 Thursday MUST BE submitted by Monday at Midnight  
 Friday MUST BE submitted by Tuesday at Midnight

Established in 1986, Strafford County Jail Industries is a factory operating inside the walls of the Strafford County Department of Corrections.

### **Our Purpose**

- To keep inmates productively occupied
- To teach work discipline and job skills
- To provide a real-world work environment where inmates are paid to produce a quality, on time product at a reasonable price
- To allow inmates to earn money for use upon release

Every month, Strafford County Jail Industries awards a certificate to an employee who has exhibited exceptional work ethic, high productivity, excellent quality and a positive attitude.

Only County or NH State Prison inmates are eligible to apply for work in Jail Industries. They apply through the Classifications Department, who will forward the names of potential employees to the Jail Industries Director, Marilyn Allen.

Marilyn Allen will then interview the candidates for employment.
